- Boys & Girls Club of the Eastern Panhandle: provides afterschool and summer programming for youth ages 6 to 18 at clubs in Berkeley, Jefferson, and Morgan counties.

State Strategic Impact grants are part of the 2024 Keep Communities Flowing Grant Program, focusing on three pillars of giving: Water, People and Communities. State Strategic Impact grants support high-impact projects and initiatives throughout American Water's national footprint.
