CAMDEN, N.J. – February 3, 2025 – The [American Water Charitable Foundation](#), a 501(c)(3) organization established by American Water (NYSE: AWK), the largest regulated water and wastewater utility company in the U.S., announced today that it launched the 2025 Water and Environment Grant Program. The Foundation invites community partners to apply for grants that promote clean water, conservation, environmental education, climate variability and water-based recreation projects.
