Pennsylvania American Water Announces Launch of American Water Charitable Foundation 2025 Water and Environment Grant Program

MECHANICSBURG, Pa. (Feb. 7, 2025) – Pennsylvania American Water is pleased to announce the launch of the American Water Charitable Foundation 2025 Water and Environment Grant Program. The Foundation invites community partners to apply for grants that promote clean water, conservation, environmental education, climate variability and water-based recreation projects.

In 2024, the American Water Charitable Foundation awarded a combined total of \$1 million to 59 organizations in 11 states, supporting organizations located in communities served by American Water, including 15 Pennsylvania-based organizations:

 Conduct a water quality assessment of fishery and impacts from abandoned mines in Southern Wyoming Valley (\$18,000)

- North Branch Land Trust, Luzerne County Implement an invasive species management plan that increases stormwater retention, water quality and public access at the Hanover Crossings Marsh Sanctuary (\$25,000)
- Old Forge Elementary PTO, Lackawanna County Restore arboretum to create an outdoor classroom with seating, shade, plants and a pond/water source (\$10,000)
- <u>Pennsylvania Envirothon</u>, Snyder County Support statewide high school environmental science competition (\$15,000)
- <u>Pennsylvania Resources Council</u>, Allegheny County Provide residents of Mon Valley with free rain barrels and education to reduce watershed

- pollution (\$10,000)
- <u>Perkiomen Watershed Conservancy</u>, Montgomery County Provide onwater education for 600 students in Norristown Area School District through The Floating Classroom Diversity, Equity and Inclusion Program (\$20,000)
- <u>Scranton Tomorrow</u>, Lackawanna County Purchase landscape materials for City Pride 2024, including soil, plants, signage, and litter abatement supplies (\$38,200)
- The Greater Pittston Land Revitalization Corporation, Luzerne County Empower the community through The Gardens at Pittston Housing Authority shared green space: fostering growth, connection and sustainability (\$10,000)
- The Pennsylvania State University, Dauphin County Engage underserved communities by exposing K-12 students to a pilot scale water treatment plant at Penn State Harrisburg (\$23,663)
- <u>Three Rivers Waterkeeper</u>, Allegheny County Provide an ambassador program focused on community engagement to protect source drinking water (\$15,000)
