**SCRANTON, Pa. (March 29, 2025)** – Pennsylvania American Water announced this morning that the boil water advisory for customers in Saw Creek Estates has been lifted. Customers were notified on March 27 of a main break that affect a storage tank, resulting in the issuance of the boil water advisory. We are pleased to report that the issue has been resolved.
