

Pennsylvania American Water to Replace 550 Lead Service Lines in New Castle

Neighborhood inspections to identify lead pipes kick off week of June 23 as part of replacement initiative.

NEW CASTLE, Pa. (June 18, 2025) – [Pennsylvania American Water](https://pennsylvaniaamwater.com/) announced it will soon begin replacing around 550 lead service lines identified in the City of New Castle. Starting the week of June 23, contractors will begin canvassing in New Castle to identify unknown service line materials. They will wear high-visibility vests and contractor ID badges. If lead or galvanized steel lines are found, customers will receive information on replacing them at no direct cost.

“At Pennsylvania American Water, delivering safe, clean, reliable and affordable water remains our top priority,” says JoAnn Hepler, manager, Water Quality and Environmental Compliance. “While our water quality meets all regulatory standards, we are dedicated to proactively replacing lead service lines to further safeguard the health, safety, and peace of mind of our customers.

Replacement of lead service lines will provide direct water quality improvements to customers and is consistent with regulatory and Pennsylvania American Water initiatives to eliminate lead service lines from the public water supply system.
