SCRANTON, Pa. (October 24, 2025) Pennsylvania American Water today issued a boil water advisory for customers in part of Frackville due to a main break along South Line Street. Approximately 975 customers are impacted.

Pennsylvania American Water experienced a loss in positive water pressure on Friday, October 24, due to a main break. A loss of positive water pressure is a signal of the existence of conditions that could allow contamination to enter the distribution system through backflow by back-pressure or back-siphonage. As a result, there is an increased chance that the water might contain disease-causing organisms.

DO NOT DRINK THE WATER WITHOUT BOILING IT FIRST. Bring all water to a rolling boil, let it boil for one minute, and cool before using; or use bottled water. You should use boil or bottled water for drinking, making ice, washing dishes, brushing teeth and food preparation until further notice.

Inadequately treated water may contain disease-causing organisms. These organisms include bacteria, viruses and parasites, which can cause symptoms such as nausea, cramps, diarrhea and associated headaches.

These symptoms are not caused only by organisms in drinking water, but also by other factors. If you experience any of these symptoms and they persist, you may wish to consult with your health care provider. People with severely compromised immune systems, infants and some elderly may be at increased risk. These people should seek advice about drinking water from their health care providers.

What happened? What is being done?

Pennsylvania American Water are currently making repairs to the main break. Repairs are anticipated to be completed overnight. Pennsylvania American Water will collect and analyze additional water quality samples including bacteria samples.
