

Boil Water Advisory Issued for Customers in Portion of City of Clairton in Pennsylvania American Water's Valley District

DRINKING WATER WARNING BOIL YOUR WATER BEFORE USING

MCMURRAY, Pa. (June 7, 2026) – Pennsylvania American Water routinely monitors the conditions in the distribution system. Early this morning, we experienced a loss of power to a booster pump station that caused a loss of positive water pressure to a water storage tank impacting the Clairton area. A loss of positive water pressure is a signal of the existence of conditions that could allow contamination to enter the distribution system through back-flow by back pressure or back siphonage. As a result, we are issuing a boil water advisory for customers in the affected area.

This notice applies to approximately 1,500 customer connections in City of Clairton in Pennsylvania American Water's Valley District.

DO NOT DRINK THE WATER WITHOUT BOILING IT FIRST. Bring all water to a rolling boil, let it boil for one minute, and cool before using; or use bottled water. You should use boil or bottled water for drinking, making ice, washing dishes, brushing teeth and food preparation until further notice.

Inadequately treated water may contain disease-causing organisms. These organisms include bacteria, viruses and parasites, which can cause symptoms such as nausea, cramps, diarrhea and associated headaches.

These symptoms, however, are not caused only by organisms in drinking water, but also by other factors. If you experience any of these symptoms and they persist, you may want to seek medical advice.

Guardians of infants and young children and people at increased risk, such as pregnant women, some of the elderly, and people with severely compromised immune systems, should seek advice from their health care advisors about drinking this water. What happened? What is being done?

The booster station is operating on back-up generator power until power is restored by the utility company. The company is also collecting and analyzing additional water quality samples, including bacterial samples.
